

ORDINANCE NO. 1046

AN ORDINANCE AMENDING ORDINANCE NO. 847 AND REGULATING THE WIDTH, CONSTRUCTION AND REPAIR OF SIDEWALKS AND CURBS IN THE BOROUGH OF DONORA, WASHINGTON COUNTY, PENNSYLVANIA.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Donora, in regular meeting assembled, and it is hereby ordained and enacted by virtue of the authority in them vested, as follows, to wit:

SECTION I. All sidewalks and curbs shall be constructed, re-constructed and repaired of concrete only according to specifications determined from time to time by the Borough Engineer and approved by Borough Council. Providing, that this section shall not operate so as to require a change in the specifications of sidewalks and curbs which are at this time constructed and in existence, but such sidewalks and curbs and the specifications thereof are hereby approved as each thereof now actually exist respectively.

SECTION II. All sidewalks situate in the Borough of Donora, shall be at least four and not more than five feet in width as specified by Borough Council from time to time, and in accordance with the locality and said sidewalk shall correspond in all instances with the existing widths of adjacent walks in the locality and shall be constructed in blocks, each block to be a length of no more than five feet in length with expansion and construction joints as specified by the Borough Engineer.

SECTION III. All sidewalks shall be constructed, re-constructed, and repaired and the grading therefore done upon the line and grade obtained by the property owner from the Borough Engineer and not otherwise.

SECTION IV. It shall be the duty and responsibility of the Borough Engineer to determine in the case of any individual property whether or not the sidewalk shall be re-constructed, or repaired; and if so the specific part or parts thereof to be re-constructed, or repaired. The Engineer may at any

time during the course of work of constructing, re-constructing or repairing any sidewalk, visit the site of such work to ascertain whether such work is being done according to requirements; and he or one of his assistants, shall visit any such place for such purpose whenever requested by the property owner. Within two days after the completion of the work of construction, re-construction, or repair of any sidewalk, it shall be the duty of the owner of the property where such work was done to notify the Borough Engineer of that fact so that he may inspect such sidewalk to determine whether the grade thereof and other required specifications as determined by the Borough Engineer and approved by Council have been observed and followed.

SECTION V. Section 1, Section 9 and Section 10 of Ordinance No. 847 and all other ordinances or parts thereof inconsistent with this ordinance or any of its provisions be and the same are hereby repealed.
