ORDINANCE NO. 1166

AN ORDINANCE of the Borough of Donora amending Ordinance No. 1162 enacted April 25, 1977.

BE IT ENACTED AND ORDAINED by the Council of the Borough of Donora, and it is hereby enacted and ordained by and with the authority of the same:

SECTION 1. That the first WHEREAS clause of Ordinance No. 1162 be and the same is hereby amended to read as follows:

WHEREAS, it is necessary that the indebtedness of the Borough of Donora be increased by the amount of Three Hundred Twenty-five Thousand Dollars (\$325,000) through the issuance of \$325,000 principal amount of Borough of Donora, General Obligation Bonds, Series of 1977, for the purpose of financing the construction of a new Maintenance Building (\$100,000) and the Architectural Plans for the same (\$15,000), the purchase of two (2) Police Cars (\$10,000) and two (2) Dump Trucks (\$32,000), the payment for certain Bridge Improvement Plans (\$22,000), the payment for a Comprehensive Community Development Plan (\$20,000), the repayment of a cost overrun from the Palmer Park project located within the Borough (\$25,000), the funding of unfunded debt (\$80,645) heretofore incurred for current operating expenses (with the prior approval of the Court of Common Pleas of Washington County, Pennsylvania), and paying the costs and expenses of preparing, issuing and marketing said General Obligation Bonds, Series of 1977, of the Borough (\$19,855).

SECTION 2. That Section 3 of Ordinance No. 1162 be and the same is hereby amended to read as follows:

SECTION 3. The nonelectoral indebtedness of the Borough of Donora be, and the same hereby is, increased by the amount of Three Hundred Twenty-five Thousand Dollars (\$325,000) for the purpose of financing the construction of a new Maintenance Building (\$100,000) and the Architectural Plans for the same (\$15,000), the purchase of two (2) Police Cars (\$10,000) and two (2) Dump Trucks (\$32,000), the payment for certain Bridge Improvement Plans (\$22,000), the payment for a overrum from the Palmer Park Project located within the Borough (\$25,000), the funding of unfunded debt (\$80,645) heretofore incurred for current operating expenses (with the prior approval of the Court of Common Pleas of Washington County, Pennsylvania) and paying the cost and expenses of preparing, issuing and marketing said 1977 Bonds (\$19,855). The period for accomplishing said construction has been estimated by the Borough Engineer as being 1 year.
