

ORDINANCE NO. 1171

(5 of 1978)

AN ORDINANCE ESTABLISHING A PARKS AND RECREATION BOARD FOR THE
BOROUGH OF DONORA.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Donora
as follows:

SECTION I. That there is hereby established a Parks and Recreation
Board for the Borough of Donora.

SECTION II. That the Board shall consist of Nine (9) members,
seven (7) of which shall be citizens of the Borough of Donora who shall be
appointed by Council along with the Chairpersons of the Budget and Finance
Committee and the Parks and Recreation Committee of the Borough Council. The
terms of the appointed members of the Board shall be five (5) years, the terms
to be staggered in such a manner so that at least one (1) member's term shall
expire annually. Vacancies, occurring otherwise than by expiration of term,
shall be filled for the unexpired term in the same manner as original
appointments. Members shall serve the Board without compensation.

SECTION III. That the Board shall maintain, operate and supervise
all public parks, play fields and outdoor and indoor recreation areas and
facilities presently owned or controlled by the Borough of Donora.

SECTION IV. That the Board shall appoint from its membership such
officers as it may deem necessary for the orderly procedure of its business
and may adopt by-laws, rules and regulations covering its procedure. It shall
make whatever rules are required governing the operation and conduct of the
recreational facilities within its jurisdiction. It shall hold regular
meetings at such time and place as it may designate.

SECTION V. That the Board may accept a grant, gift, bequest or
donation of services, equipment, real estate, or money from any individual or

group. The Board shall have no authority to enter into any contract or incur any obligation binding upon the Borough of Donora.

SECTION VI. That the Board shall have the power to appoint and compensate a Director of Recreation who shall possess the necessary qualifications and who shall have demonstrated by actual work his ability to organize and direct a community recreation system and such other personnel as may be deemed necessary and recommended by the Director of Recreation. The Director of Recreation shall serve as an ex-officio member of the Board.

SECTION VII. That funds appropriated by the Council of the Borough of Donora and budgeted to the Board shall be dispersed by the responsible officers of the Board and the responsible official of the Borough of Donora. These funds shall be for the ordinary expenses of maintaining, operating, and supervising all outdoor and indoor recreation areas and facilities. Funds received by the Board from sources other than budget appropriations shall be deposited by the Borough of Donora to the credit and for the use of the Board and disbursed as the above budget funds are dispersed.

SECTION VIII. That the Board shall submit an annual report and such other reports as needed to the Council at such times as may be designated or requested by Council. The fiscal year of the Board shall conform to that of the Borough of Donora.

SECTION IX. That all ordinances or parts of same inconsistent with this ordinance are hereby repealed.
