

ORDINANCE NUMBER 119

PAVING OF THIRD STREET BETWEEN THOMPSON AND McKEAN

AN ORDINANCE authorizing the grading, curbing and paving of Third Street, between Thompson and McKean avenue, Borough of Donora, Washington County, Pennsylvania, and providing for the payment of the costs and expenses thereof.

WHEREAS, It appears by the petition and affidavit, accepted and approved by the Burgess and Council, of the Borough of Donora, Washington County, that two-thirds of the owners of the real property representing not less than two-thirds in number of feet of the properties fronting or abutting on Third Street, between McKean and Thompson avenue, have petitioned said Council to enact an ordinance authorizing and ordering the grading, curbing and paving with vitrified brick, or Third street, between said points, therefore:

Be it ordained and enacted by the Council of the Borough of Donora, Washington County, Pennsylvania, in regular meeting assembled, and it is hereby ordained and enacted by the authority of the same:

Section 1. That Third street, between McKean and Thompson avenues, in the said borough, and the same is hereby authorized and ordered to be graded, curbed and paved with vitrified brick. Said portion of Third street to be graded, curbed and paved according to the plans and specifications of the Borough Engineer, approved by the President of the Council and the Committee on Highways and Sewers.

Section 2. That the President of Council and Chairman of the Committee on Highways and Sewers are hereby authorized and directed to advertise for bids and receive proposals for the grading curbing and paving of said portion of Third street as aforesaid; they are hereby authorized, upon the approval of the same by the Council, to let contract or contracts therefor, to any responsible party or parties, such being the lowest bidder or bidders, such party or parties to give satisfactory security to complete the work in strict conformity with the plans and specifications which shall be furnished by the Borough Engineer so approved as aforesaid, and work shall be done under the direction and supervision of the Borough Engineer and Committee on Highways and Sewers.

Section 3. That the costs and expenses of grading, curbing and paving of said portion of Third street shall be ascertained upon the completion of the same, and be assessed by this Council on the owners of the real estate abounding and abutting on said portion of Third street, by an equal assessment on the foot front bounding and abutting thereon; said assessment shall be made and collected according to the provisions of the act of Assembly of the Commonwealth of Pennsylvania, ap-

proved April 23rd, 1889. P. L. 44.

Section 4. That all ordinances or parts thereof in conflict with the provisions of this ordinance in conflict with the provisions of this ordinance be and the same are hereby repealed.
