

ORDINANCE NUMBER 174  
EXTENSION OF 9TH STREET SEWER

AN ORDINANCE authorizing the adoption and construction of a Public Sewer, to be known as "Extension of Ninth Street Sewer, in the Borough of Donora, Washington County, Pennsylvania."

WHEREAS, it appears necessary to the general health and public welfare of the citizens of the Borough of Donora, and to provide for a convenient and sufficient out-let of the sewerage from the present Ninth Street Sewer, in said borough, the accumulations of which sewerage from said Ninth Street Sewer being a menace and dangerous to the public health, that a public sewer be constructed to begin at the East end of Ninth Street Sewer, as at present located, and running along the route hereinafter mentioned, therefore.-

Be it ordained and enacted by the Council of the Borough of Donora, Washington County, Pennsylvania, in a regular meeting met and it is hereby ordained and enacted by the authority of the same,

Section 1---That a Public Sewer be and the same is hereby directed to be adopted and constructed, in said Borough along the following route, to wit: Beginning at the East end of the Ninth Street Sewer as at present located and running thence Eastwardly along said Ninth Street to Meldon Avenue, and thence Southwardly along said Meldon Avenue to Eighth Street, and to connect with the public sewer now constructed on said Eighth Street; said sewer hereby authorized shall be known as "Extension of Ninth Street Sewer."

Section 2---That said sewer shall be constructed of double strength Terra Cotta sewer pipe, of the diameter of twenty-four (24) inches, and shall be so constructed as aforesaid in accordance to the plans and specifications of the Borough Engineer, approved by the President of the Council and the Committee on Highways and Sewers, and the work on said sewer shall be done under the supervision of the Borough Engineer and the said Committee on Highways and Sewers.

Section 3---That the President of Council, and the Chairman of the Committee on Highways and sewers are hereby authorized and directed to advertise for bids and receive proposals for the construction of said sewer, as aforesaid; they are hereby authorized, upon the approval of the same, by the said council, to let contract or contracts therefor to any responsible party or parties, such party or parties being the lowest bidder or bidders, and upon such party or parties giving satisfactory security to complete the work in strict conformity to the plans and specifications which shall be furnished by the Borough Engineer, so approved as aforesaid.

Section 4---That the cost and expense of the adoption and construction of said sewer shall be paid by the Borough of Donora.

Section 5---That any ordinance in conflict with any of the provisions of this ordinance, be and the same are hereby repealed, so far as the same affects this
