

ORDINANCE NUMBER 188

ALLEN AVENUE AND FIRST STREET SEWER

AN ORDINANCE authorizing the adoption and construction of a public sewer on Allen avenue and First street on the route hereinafter mentioned, and providing for the payment of the cost of the construction thereof.

WHEREAS, it appears by the petition and affidavit, accepted and approved by the Borough of Donora, Washington County, Pennsylvania, that a majority of the owners of the real property, both in number and point of interest, bounding and abutting on First street and Allen Avenue, along the route hereinafter mentioned, in said borough, have petitioned said council for the enactment of an ordinance authorizing the adoption and construction of a public sewer on First Street and Allen Avenue, between the points aforesaid, and the said council is desirous of enacting such ordinance, and constructing said sewer, therefore.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Donora, in the County of Washington and State of Pennsylvania, in regular meeting met, and it is hereby ordained and enacted by the authority of the same,

SECTION 1. That a public sewer be, and the same is hereby authorized to be adopted and constructed in First Street and Allen avenue, along the following route, to wit: Beginning on First street, at the west line of lot No. 30, in block No. 15, and running along First street.....feet to Allen avenue, and thence along Allen avenue, a distance of 625 feet, to the north line of Lot No. 1, in block No. 42, in said borough; said sewer to be constructed of Terra Cotta sewer pipe of diameter as follows; for a distance of 700 feet on First street 24 inches, and for a distance of 625 on Allen avenue 10 inches, and said sewer shall be constructed in strict conformity to the plans and specifications of the borough engineer, approved by the President of council and the Committee on Highways and Sewers of said borough.

SECTION 2. That the President of council and the Chairman of the Committee on Highways and Sewers are hereby authorized and directed to advertise for bids, and receive proposals for the construction of said sewer as aforesaid; are hereby authorized, upon the approval of the same by council, to let contract or contracts therefor to any responsible party or parties, such being the lowest bidder or bidders, and upon such party or parties giving satisfactory security to complete the work in strict conformity with plans and specifications which shall be furnished by the Borough Engineer, so approved as aforesaid, and work shall be done under the supervision and direction of the Borough Engineer and the Committee on Highways and Sewers.

SECTION 3. That the costs and expenses of the construction of said sewer shall be ascertained upon the completion of the same, and shall be assessed as a sewer tax, upon the properties abounding and abutting on said First street and Allen avenue between

the points aforesaid in accordance with the foot front rule, and be collected under the provisions of the Act of Assembly of Pennsylvania, approved May 15, 1889, and the several supplements and amendments thereto, relating to and regulating the same.

SECTION 4. All ordinances, or parts thereof, in conflict with any of the provisions of this ordinance be and the same are hereby repealed.
