

ORDINANCE NUMBER 192

SEWER ON HESLEP AVENUE 8TH STREET TO KOEHLER AVENUE.

AN ORDINANCE, authorizing the adoption and construction of a system of a public sewerage on Heslep avenue, in the Borough of Donora, along the route hereinafter mentioned, and providing for the payment of the cost of the construction thereof:-

Whereas, it appears by their petition, accepted and approved by the Council of the Borough of Donora, Washington County, Pennsylvania, that a majority of the owners of the real property abutting and adjoining on Heslep avenue, along the route hereinafter mentioned, have petitioned said council for the enactment of an ordinance authorizing the adoption and construction of a system of public sewerage on Heslep avenue, in said borough, between the points aforesaid, and the said council being desirous of enacting such ordinance, and constructing said system of public sewerage, therefore:-

Be it ordained and enacted by the Council of the Borough of Donora, Washington, County, Pennsylvania, in a lawful meeting met, and it is hereby ordained and enacted by the authority of the same:-

Section 1---That a system of public sewerage be, and the same is hereby authorized to be adopted and constructed on Heslep avenue in said borough, along the following route, to wit: Beginning at the intersection of the present Eighth street sewer with Heslep avenue, and running thence extending along Heslep avenue for a distance of 570 feet to Koehler avenue: the sewers of said system shall be constructed of terra cotta sewer pipe, and shall consist of one storm, and one sanitary main, laid together the full length of 570 feet, of the size of 12 inches and 8 inches, respectively, with the connections, etc., of, and shall be constructed in strict, conformity to the plans and specifications made therefor by the Borough Engineer, approved by the President of Council and the Committee on Highways and Sewers of said borough.

Section 2---That the proper officers of said borough are hereby authorized and directed to enter into a contract with J. W. Hale for the construction of said sewerage system, in accordance with, for the price and upon the terms contained in his bid therefor dated May 16, 1910, and as accepted by this council; this council having prior to the acceptance of said bid, advertised for and received competitive bids for the construction of said sewerage system and the said bid of J. W. Hale being the lowest received as aforesaid, was therefore accepted by said council.

Section 3---That the cost of the construction of said above mentioned sewerage system shall be ascertained upon the completion of the same, and shall be assessed by this Council as a Sewer Tax Upon the properties abutting and adjoining on said Heslep avenue, between the points aforesaid, in accordance with the foot front

rule and be collected under the provisions of the Act of Assembly of Pennsylvania, approved May 15, 1889, and the several supplements and amendments thereto, relating to and regulating the same.

Ordained and enacted into an ordinance this 30th day of May, A. D. 1910.
