

ORDINANCE NUMBER 20

THOMPSON AVENUE PAVING FROM FIRST TO EIGHTH STREET

AN ORDINANCE to authorize and require the grading, curbing and paving of Thompson avenue between First and Eighth streets in the Borough of Donora, Washington County, Pennsylvania, and to authorize the President of Council and Chief Burgess of said Borough of Donora to advertise for bids, and to execute and deliver contracts for the construction of the same, as well as to assess benefits and award damages incurred by the grading, curbing, and paving of said section of Thompson Avenue, according to the Act of Assembly in such cases made and provided.

Whereas, a majority of the property owners both in interest and number abutting on a certain section of Thompson avenue in said Borough of Donora have presented their petition "in due form and sworn to according to law" to the Town Council of said Borough of Donora to grade, curb and pave with vitrified brick that certain section of Thompson avenue between First and Eighth streets, and that the benefits, damages, costs and expenses of such improvement be assessed on the abutting property owners according to an Act of Assembly in such cases made and provided; and whereas said Town Council deeming such improvement needful and necessary. Now therefore,

SECTION 1. Be it ordained and enacted by the Borough of Donora, of Washington County, Pennsylvania, in Council assembled and it is hereby ordained and enacted by the authority of the same: that a certain section of Thompson avenue between First and Eighth streets in said Borough of Donora, be and the same is hereby required to be graded, curbed and paved with vitrified brick, according to the plans and specifications to be prepared by the borough engineer and committee on Highways and Sewers, and to be approved by said Town Council.

SECTION 2. The President of Council and Chief Burgess are hereby authorized and directed to advertise for proposals for the grading, curbing and paving of said section of Thompson avenue between First and Eighth streets in said Borough of Donora as aforesaid, and to execute and deliver, for and on behalf of said Borough, proper contracts and agreements for the making of the improvement aforesaid, upon such terms and with such contractors as the Council shall approve and direct.

SECTION 3. The benefits, damages, costs and expenses of such grading, curbing and paving as aforesaid, shall be assessed and collected according to the Act of Assembly approved the 16th day of May, A. D. 1891.
