ORDINANCE NUMBER 45 PROHIBITING WAGONS AND ETC. TO PARK ON STREETS

AN ORDINANCE prohibiting the hitching or standing of any beast or beasts, or of wheeled carriages for the carrying of persons, wagons, carts, drays or other vehicles, in or on the highways, streets, lanes or alleys of the borough of Donora, and fixing a penalty for a violation of this ordinance.

Be it ordained and enacted by the Burgess and Council of the Borough of Donora, in the County of Washington and State of Pennsylvania, and it is hereby ordained and enacted by the authority of the same.

Section I. That it shall be unlawful for the owner or owners, or the driver or drivers, or the person or persons in whose possession or under whose control the same may be, of any beast of beasts, or of wheeled carriages for the carrying of persons, wagons, cars, drays or other vehicles, to hitch or leave standing any beast or beasts, or wheeled carriage for the carrying of persons, wagons, carts, drays, or other vehicles, in or on any of the highways, streets, lanes or alleys of said borough.

Section 2. The police of said borough, and each of them, are hereby authorized and required to strictly enforce the provisions of this ordinance, and to arrest on view all persons violating the same, and bring them before the Burgess of said borough, who shall proceed to try them summarily according to law, and upon conviction the said burgess shall impose a fine not exceeding five (\$5.00) dollars, or sentence them to imprisonment in the borough lock-up for a period not exceeding five days, either or both at the discretion of said burgess.

Section 3. That this ordinance shall not apply to wheeled carriages for the carrying of persons, wagons, carts, or other vehicles left standing in or on the highways, streets, lanes or alleys of said borough, on account of an accident or from other causes over which the owner or owners, or the driver or drivers, or the person or persons in whose possession and under whose control the same may be, have no control; providing that in such case, where it is necessary for such vehicles aforesaid to remain in or on the highways, streets, lanes or alleys aforesaid over night, that the persons made responsible under this ordinance shall place thereon and keep burning continuously throughout such night sufficient red signal light or lights as may be necessary to warn the traveling public of the presence of said vehicle as aforesaid; and also providing, that if such red signal light or lights are not so placed and kept as aforesaid, that the owner or owners, driver or drivers, or the person or persons in whose possession or under whose control the same may be, shall then, and they are hereby so made, subject to arrest and conviction and shall be punished as hereinbefore provided for violation of this ordinance.
