

ORDINANCE NUMBER 633
CARROLL TOWNSHIP ANNEX.

AN ORDINANCE authorizing the annexation of land adjacent to the Borough of Donora, Pa., and situate in Carroll Township, Washington County, Pa.

WHEREAS the School District of the Borough of Donora, Pa., has recently acquired the title in fee to the parcel of land hereinafter described, and has by proper petition, over seal of such School District, requested the Council of the Borough of Donora to annex such property to the Borough of Donora so that it may thereafter be and form a part of the Borough of Donora; and

WHEREAS the School District of the Borough of Donora is the sole owner of the property hereinafter described; and

WHEREAS by Section 425 of the Borough Code of 1927 the Borough of Donora is given power by ordinance to annex the aforesaid land situate in Carroll Township, Washington County, Pa. upon petition of a majority of the freeholders of the territory to be annexed; therefore,

BE IT ORDAINED AND ENACTED by the Council of the Borough of Donora, in regular meeting assembled, and it is hereby ordained and enacted by virtue of the authority in them vested, as follows, to wit:

SECTION 1---That the following described parcel of land adjacent to the Borough of Donora, situate in Carroll Township, be and the same is hereby authorized and directed to be annexed to and to become a part of the Borough of Donora, to wit:

Beginning at a point on the West side of Washington Alley, which said point is opposite and across Washington Alley from the dividing line between lots numbered 20 and 21 in block numbered 39 of the Union Improvement Company's Plan of Lots of the Borough of Donora; thence South $82^{\circ} 58'$ West, a distance of 436 feet to a point; thence North $52^{\circ} 20'$ West, 558.57 feet to a point; thence North $1^{\circ} 39'$ West, 322.88 feet to a point; thence North $16^{\circ} 35'$ East, 218.44 feet to a point; thence North $15^{\circ} 28'$ West, 202.55 feet to a point; thence South $73^{\circ} 08'$ East, 73.86 feet to a point; thence South $73^{\circ} 23'$ East, 758.74 feet to a point on the West side of Washington Alley and what was formerly the Westerly line of Washington Alley, before being vacated by the Borough of Donora, South $14^{\circ} 34'$ West, a distance of 340.94 feet to a point; thence South $77^{\circ} 11'$ East, a distance of 114.60 feet to a point; thence South $7^{\circ} 02'$ East, 424.48 feet along the Westerly line of what was formerly Washington Alley, to the place of beginning.

SECTION 2--- That in conformity with Section 426 of the Borough Code of 1927, the proper officers of the Borough of Donora are directed to certify a copy of this ordinance, together with a description and a plot showing the courses and distances of the boundaries of the Borough before and after such proposed annexation, and to file the same in the Court of Quarter Sessions of Washington County, Pa., and are further directed to serve notice of such filing upon the office of the County Commissioners of Washington County, Pa.

SECTION 3---That the Engineer of the Borough of Donora be and he is hereby directed to change the official maps of the Borough of Donora by incorporating the proposed territory therein.
