

ORDINANCE NUMBER 665

RE-ESTABLISHING THE GRADE OF CYPRESS ALLEY FROM 8TH TO 9TH STREETS.

AN ORDINANCE re-establishing the grade of Cypress Alley from the North curb line of Eighth Street to the South curb line of Ninth Street, in the Borough of Donora, Pa.

BE IT ORDAINED AND ENACTED by the Chief Burgess and Council of the Borough of Donora, Pa., and it is hereby ordained and enacted by the same, by virtue of the powers in them vested, as follows, to wit:

SECTION 1---That Cypress Alley, from the North curb line of Eighth Street to the South curb line of Ninth Street, in the Borough of Donora, Pa., be and the same is hereby re-established as follows:

.WEST CURB LINE: Beginning at the North curb line of Eighth Street at an elevation of 782.35 feet; thence descending at the rate of 9.50% for a distance of 10 feet to an elevation of 781.40 feet; thence ascending at the rate of 0.64% for a distance of 250.0 feet to an elevation of 783.0 feet thence ascending at the rate of 1.78% for a distance of 146.0 feet to an elevation of 785.60 feet; thence ascending at the rate of 7.10% for a distance of 10 feet to an elevation of 786.31 feet at the South curb line of Ninth Street.

EAST CURB LINE: Beginning at the North curb line of Eighth Street at an elevation of 781.12 feet; thence descending at the rate of 5.20% for a distance of 10 feet to an elevation of 780.60 feet; thence ascending at the rate of 4.65% for a distance of 20.0 feet to an elevation of 781.53 feet; thence ascending at the rate of 0.64% for a distance of 230.0 feet to an elevation of 783.0 feet; thence ascending at the rate of 1.78% for a distance of 130.0 feet to an elevation of 785.32 feet; thence ascending at the rate of 1.125% for a distance of 16.0 feet to an elevation of 785.50 feet; thence ascending at the rate of 3.0% for a distance of 10 feet to an elevation of 785.80 feet at the South curb line of Ninth Street.

SECTION 2---That the Borough Engineer enter the same upon the records of the Borough.

SECTION 3---That all ordinances or parts of ordinances in conflict herewith in so far as they conflict, are hereby repealed.
