

ORDINANCE NUMBER 669

AMENDMENT OF ORDINANCE #666.

AN ORDINANCE amending Ordinance No. 666 of the Borough of Donora, Pa.

WHEREAS by Ordinance No. 666 the Borough of Donora reduced the salaries of its employees by reason of the present depression; and

WHEREAS in Section 1 of such ordinance the salary of the Night Lieutenant was omitted from the list therein mentioned, and it is now desired to remedy such omission; and

WHEREAS it is desired that Section 2 of such ordinance be also amended so as to fix the wages of certain other employees on an hourly rather than a daily basis; therefore,

BE IT ORDAINED AND ENACTED by the Council and Chief Burgess of the Borough of Donora, and it is hereby ordained and enacted by virtue of the authority in them vested as follows, to wit:

SECTION 1---That Section 1 of Ordinance No. 666 be amended to read as follows:

"Section 1. That as of November 1, 1931, the Police of the Borough of Donora shall receive for their services annually, to be paid pro rata in bi-monthly periods, the following amounts:

Chief of Police, the sum of.....	\$2230.20
Desk Sergeant, the sum of.....	1633.50
Third Year Patrolmen, the sum of.....	1801.44
Second Year Patrolmen, the sum of.....	1710.00
First Year Patrolmen, the sum of.....	1620.00
Night Lieutenant, the sum of.....	1944.00

SECTION 2---That Section 2 of Ordinance No. 666 be amended to read as follows:

"Section 2. That as of November 1, 1931, the wages of the employees of the various departments of the Borough of Donora be and they are hereby fixed as follows, to wit:

Special Service Man, the sum of.....	\$.60 $\frac{1}{2}$ per hour of actual service.
Garbage laborers, the sum of.....	.50 per hour of actual service
Truck drivers, the sum of.....	..50 per hour of actual service
Laborers, the sum of.....	.40 per hour of actual service
Borough Clerk, the sum of.....	180.00 per month.
Garbage Furnace man, the sum of.....	162.00 per month.
Firemen, the sum of.....	.80 per hour of actual service
Fire truck driver, the sum of.....	132.03 per month.
Street Commissioner, the sum of.....	234.00 per month.
Assistant Engineer, the sum of.....	.50 per hour of actual service
Solicitor, the sum of.....	135.00 per month"

SECTION 3---That all ordinances or parts of ordinances in conflict herewith, in so far as they conflict, are hereby repealed.


