

ORDINANCE NUMBER 670

TAX LEVY FOR 1932

AN ORDINANCE relating to the finances of the Borough of Donora, Pa., by levying the annual tax for the year 1932, and setting apart and appropriating to the certain items of expenditure therein enumerated, the revenues derived from all sources during the said year.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Donora, Washington County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same as follows, to wit:

SECTION I.

That the annual tax, being at the rate of eleven mills on the dollar of the valuation for county purposes or at the rate of \$1.10 per each \$100.00 of valuation, approximating the sum of \$137,222.69, be and the same is hereby levied for the year 1932 upon all property, offices, professions and persons within the limits of the Borough of Donora, made taxable by the laws of the Commonwealth of Pennsylvania for county rates and levies, of which said tax of \$137,222.69, the sum of \$57,689.43, and being at the rate of 4.632 plus mills on the dollar on the said valuation, shall be for the sinking funds heretofore created for the payment of the principal, interest, and state tax on the funded debt of said Borough, and of which tax the sum of \$79,533.26, being at the rate of 6.368 minus mills on the dollar on said valuation, shall be for general Borough purposes.

SECTION 2.

That the said annual tax of \$137,222.69, together with the revenues to be derived to the Borough during the said year of 1932 from all sources other than from said tax levy, and as estimated by the Finance Committee of said Council at \$10,149.00 making a total sum of all revenues of \$147,371.69, be and the same is hereby set apart and appropriated to the several items of expenditure and in the amount of each thereof respectively as follows, to wit:
