AN ORDINANCE authorizing an election on the question of increasing the indebtedness of the Borough of Donora by the amount of Two Hundred Seventy-Five Thousand (\$275,000.00) Dollars for the purpose of providing a fund which shall be applied, as Council may determine, towards the payment of the cost and expense of the construction and installation of an adequate and modern sewage system for the Borough, and giving notice thereof.

WHEREAS it is necessary that the bonded indebtedness of the Borough of Donora, County of Washington, Commonwealth of Pennsylvania, be increased for the purpose of providing a fund which shall be applied, as Council may determine, towards the payment of the cost and expense of the construction and installation of an adequate and modern sewage system for the Borough; and

WHEREAS the corporate authorities of said Borough, by ordinance duly passed and enacted into law, have expressed their desire to increase the bonded indebtedness of said Borough of Donora by the amount of Two Hundred Seventy-Five Thousand (\$275,000.00) Dollars for the purpose of providing a fund which shall be applied, as Council may determine, towards the payment of the cost and expense of the construction and installation of an adequate and modern sewage system for the Borough.

NOW THEREFORE, BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by and with the authority of the Chief Burgess and Council of the Borough of Donora, County of Washington, Commonwealth of Pennsylvania, that a public election be and the same is hereby authorized to be held on the 7th day of November, A. D. 1933, for the purpose of obtaining the assent of the electors of said Borough of Donora for an increase in the bonded indebtedness of said Borough of Donora by the amount of Two Hundred and Seventy-Five Thousand (\$275,000.00) Dollars, for the purpose of providing a fund which shall be applied, as Council may determine, towards the payment of the cost and expense of the construction and installation of an adequate and modern sewage system for the Borough, and that notice of said election be given according to law as follows:

The corporate authorities of the said Borough of Donora, by Ordinance No. 683, enacted the 5th day of September, A. D. 1933, and approved by the Chief Burgess on the 18th day of September, A. D. 1933, signified and expressed their desire for such increase of indebtedness.

The amount of the last assessed valutation of taxable property in the Borough of Donora is \$12,473,135.00.

The total amount of the present actual debts of said Borough of Donora is \$551,000.00, against which there is a principal credit in the sinking fund of \$55,513.29.

The amount of the proposed increase in the indebtedness of said Borough of Donora is \$275,000.00.

The percentage of the proposed increase in the indebtedness of said Borough of Donora (computed upon the last assessed valuation is two and twenty-two hundredths plus (2.22+ %) per centum.

The proposed increase of indebtedness is for the purpose of providing a fund which shall be applied, as Council may determine, towards the payment of the cost and expense of the construction and installation of an adequate and modern sewage system for the Borough.
