## ORDINANCE NO. 706

AN ORDINANCE fixing the time for the regular meetings of the Council of the Borough of Donora and the manner in which and by whom special meetings of Council may be called.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Donora, in regular meeting assembled, and it is hereby ordained and enacted by virtue of the powers in them vested, as follows, to wit:

SECTION 1. That, until otherwise provided by ordinance hereafter duly enacted, the Council of the Borough of Donora shall meet regularly at 7:00 o'clock P.M., Eastern Standard Time, (or Daylight Savings Time during such portion of any year as Council shall by resolution designate.), on the first and third Tuesdays of each month, in the Council rooms of the Borough Building on Thompson Avenue.

SECTION 2. That a special meeting of Council may be called by the President of Council, or any two members of Council acting personally or through the Borough Secretary, upon twelve (12) hours notice to all members of Council, and it shall be the duty of any member of Council receiving such notice to attend such meeting unless prevented by such matters as would legally justify such members absence from a regular meeting unless excused by the member or members calling such a meeting.

SECTION 3. That the call of any special meeting must be filed in writing with the Borough Secretary at or before the hour fixed for the holding of such meeting; shall contain a statement of the purpose for which such meeting is called; shall be signed by the member or members who have requested such special meeting; and no business save that for which such meeting is called shall be considered unless all members of Council are present and unanimously agree to the consideration of other business.

SECTION 4. That any member of Council shall be deemed to have been given adequate notice of such specially called meeting if he had actual knowledge of the call of such meeting at least twelve hours previous to the time fixed therefor, regardless of the manner in which or means by which or persons by whom such fact was communicated to him.

SECTION 5. That all special meetings must be held at the regular meeting place of Council unless a different place of meeting is unanimously agreed to by all members of Council.

SECTION 6. That nothing herein contained shall be held to prevent a meeting of Council being held at any time or at any place when all members of Council have signed and filed with the Secretary a written waiver of the necessity of specified notice and containing a provision that they shall be bound by the proceedings had at such meeting with the same force and effect as if such were a regular meeting of Council.
