ORDINANCE NUMBER 74

SEWER ON THIRD STREET -- PENNSYLVANIA R. R. LOT 18 to B. 16

AN ORDINANCE authorizing the adoption and construction of a certain sewer on Third Street, in the borough of Donora, Washington county, Pennsylvania.

Whereas, it appears necessary to the general helath and public welfare of the citizens of the Borough of Donora, and to provide for a convenient and sufficient out-let for the sewerage from other sewers of said borough, that an additional sewer should be constructed on Third street between the points hereinafter designated.

And whereas, the Council of said borough deems it advisable and proper that such sewer be so constructed, and the costs and expenses thereof be paid by said borough, therefore,

Be it ordained and enacted by the Council of the borough of Donora, in the county of Washington and State of Pennsylvania, in regular meeting assembled, and it is hereby ordained and enacted by the authority of the same.

Section 1. That an additional public sewer be adopted and constructed on Third street, between the following designated points, to wit: at the man hole at the foot of Third street, at the Pennsylvania R. R. right of way, $7\frac{1}{4}$ feet from same, continuing up Third street to lot 18, Block 16.

Section 2. That size of the sewer shall be 5 feet x 3 feet, egg shaped, same to be built of brick.

Section 3. That said sewer shall be constructed according to the plans and specifications of the Borough Engineer, approved by the president of said Council and the Committee on Highways and Sewers.

Section 4. That the President of Council and Chairman of the Committee on Highways and Sewers are hereby authorized and directed to advertise for bids and receive proposals for the construction of said sewer as aforesaid; they are hereby authorized, upon the approval of the same by the said council, to let contract or contracts therefore to any responsible party or parties, such being the lowest bidder or bidders, such party or parties to give satisfactory security to complete

the work in strict conformity with the plans and specifications which shall be furnished by the Borough Engineer so approved as aforesaid, and work shall be done under the direction and supervision of the Borough Engineer.

Section 5. That the costs and expenses of the adoption and construction of said sewer shall be paid by the Borough of Donora.

Section 6. That any ordinance or ordinances in conflict with the provisions of this ordinance, be and the same are hereby repealed, so far as the same affects this ordinance, or any of the provisions hereof.
