ORDINANCE NO. 753

AN ORDINANCE establishing the grade of Brokaw Avenue from Chestnut Street to Walnut Street in said Borough.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Donora, in legal meeting assembled, and it is hereby ordained and enacted by virtue of the authority in them vested, as follows, to wit:

SECTION 1. That the grade of Brokaw Avenue, from Chestnut Street to Walnut Street, be and the same is established as follows:

WEST CURB LINE: Beginning at the North curb line of Chestnut Street, at an elevation of 923.77; thence ascending at the rate of 1.615%, a distance of 180.0 feet to an elevation of 926.68; thence by a convex parabola, a distance of 40.0 feet to an elevation of 926.3; thence descending at the rate of 3.5%, a distance of 60.0 feet to an elevation of 924.2; thence by a convex parabola, a distance of 40.0 feet to an elevation of 921.96; thence descending at the rate of 7.7%, a distance of 60.16 feet to an elevation of 917.33 at the south curb line of Walnut Street.

EAST CURB LINE: Beginning at the North curb line of Chestnut Street, at an elevation of 921.78; thence ascending at the rate of 5.6%, a distance of 50.0 feet to an elevation of 924.58; thence ascending at the rate of 1.615%, a distance of 130.0 feet to an elevation of 926.68; thence by a convex parabola, a distance of 40.0 feet to an elevation of 926.3; thence descending at the rate of 3.5%, a distance of 60.0 feet to an elevation of 924.2; thence by a convex parabola, a distance of 40.0 feet to an elevation of 924.2; thence by a convex parabola, a distance of 40.0 feet to an elevation of 924.2; thence by a convex parabola, a distance of 40.0 feet to an elevation of 921.32; thence descending at the rate of 10.91%, a distance of 55.71 feet to an elevation of 915.24 at the south curb line of Walnut Street.
