ORDINANCE NUMBER 84 MCKEAN AVEUNE GRADE

AN ORDINANCE fixing and establishing the grade of McKean avenue, in the Borough of Donora, Washington county, Pennsylvania.

Be it ordained and enacted by the Town Council of the Borough of Donora, in the County of Washington and State of Pennsylvania, in regular meeting assembled, and it is hereby ordained and enacted by the authority of the same,

Section 1. That the grade of McKean avenue, in said borough, be and the same is hereby fixed and established as follows, to wit:

East Curb line, -- Beginning at the North East corner of First street at an elevation of 820.29 feet and falling at the rate of 1 per cent for a distance of 150 feet to an elevation of 818.79 feet; thence falling at the rate of 2.504 per cent a distance of 173.4 feet to an elevation of 808.87 feet thence by a parabola a distance of 40 feet to an elevation of 807.12 feet; thence falling at the rate of 6.34 per cent a distance of 207 feet to an elevation of 794 feet; thence level level across Third street a distance of 30 feet, thence rising at the rate of 6.42 per cent a distance of 257 feet to an elevation of 810.5 feet; thence level across Fourth street a distance of 30 feet; thence falling at the rate of 2.492 per cent a distance of 301 feet to the South East corner of Fifth Street at an elevation of 803.79 feet and falling at the rate of 1.918 per cent at a distance of 425.02 feet to an elevation of 795.64 feet thence falling at the rate of 3.9 per cent for a distance of 107.57 feet at an elevation of 791.44 feet to the South East corner of Sixth Street; thence beginning at the North East corner of Sixth Street at an elevation of 791.41 feet and rising at the rate of 4 per cent for a distance of 221 feet to an elevation of 800.25 feet thence by a parabola a distance of 40 feet to an elevation of 800.85 feet thence falling at the rate of 1 per cent for a distance of 221 feet at an elevation of 798.65 feet thence level across Seventh Street a distance of 30 feet thence falling at the rate of 1.409 per cent for a distance of 30 feet thence falling at the rate of 1.409 per cent for a distance of 504 feet at an elevation of 791.55 feet at the South East corner of Eighth street.

West Curb line. -- Beginning at the North West corner of First Street at an elevation of 821.29 feet; thence falling at the rate of 1 per cent for 150 feet to an elevation of 819.79 feet; thence falling at the rate of 2.504 per cent for a distance of 230 feet to an elevation of 814.03 feet; thence level across Second Street a distance of 30 feet; thence falling at the rate of 2.4 per cent for a distance of 173.4 feet to an elevation of 809.87 feet; thence by a parabola a distance of 40 feet to an elevation of 808.12 feet; thence falling at the rate of 6.34 per cent for a distance of 207 feet to an elevation of 795 feet; thence level across Third Street a distance of 30 feet; thence rising at the rate of 6.42 per cent for a

distance of 257 feet to an elevation of 811.5 feet; thence level across Fourth Street a distance of 30 feet; thence falling at the rate of 2.492 per cent for a distance of 301 feet to an elevation of 804 feet at the South West corner of Fifth Street; thence beginning at the North West corner of Fifth Street at an elevation of 804.74 feet and falling at the rate of 1.93 per cent for a distance of 420 feet to an elevation of 796.64 feet; thence falling at the rate of 4 per cent for a distance of 104.84 feet to an elevation of 792.45 feet at the South West corner of Sixth Street; thence beginning at the North West corner of Sixth Street at an elevation of 792.41 feet and rising at the rate of 4 per cent for a distance of 221 feet to an elevation of 799.65 feet; thence level across Seventh Street a distance of 30 feet; thence falling at the rate of 1.409 per cent for a distance of 504 feet to an elevation of 792.55 feet at the South West corner of Eighth Street.

Section 2. That all ordinances or parts thereof in conflict with any of the provisions of this ordinance, be and the same are hereby repealed.
