ORDINANCE NUMBER 88 GRADE OF SECOND STREET

AN ORDINANCE fixing and establishing the grade of Second Street, in the Borough of Donora, Washington County, Pennsylvania.

Be it ordained and enacted by the Town Council of the Borough of Donora, in the County of Washington and State of Pennsylvania, in regular meeting assembled, and it is hereby ordained and enacted by the authority of the same.

Section 1. That the grade of Second street, in said borough, be and the same is hereby fixed and established as follows, to wit:

North curb line -- Beginning at the west curb line of Meldon Avenue at an elevation of 783.6 feet and rising at the rate of 12.314 per cent for a distance of 239 feet to an elevation of 813.03 feet at the east curb line of McKean Avenue; thence rising at the rate of 2.777 per cent for a distance of 36 feet to an elevation of 814.03 feet at the west curb line of McKean avenue; thence rising at the rate of 14.335 per cent for a distance of 237 feet to an elevation of 848 feet at the east curb line of Thompson avenue; thence rising at the rate of 5 per cent for a distance of 30 feet to an elevation of 849.5 feet at the west curb line of Thompson avenue; thence rising at the rate of 11 per cent for a distance of 70.72 feet to an elevation of 857.28 feet at the west curb line of Carrol avenue; thence rising at the rate of 18.834 per cent for a distance of 189.65 feet to an elevation of 893 feet at the east curb line of School street; thence rising at the rate of 4.166 per cent for a distance of 24 feet to an elevation of 894 feet at the west curb line of School street; thence rising at the rate of 12.55 per cent for a distance of 183.26 feet to an elevation of 917 feet at the east curb line of Kenric avenue; thence beginning at the west curb line of Kenric Avenue at an elevation of 918 feet and rising at the rate of 5.828 per cent for a distance of 506.17 feet to an elevation of 947.50 feet at the east curb line of Allen Avenue; thence beginning at the west curb line of Allen avenue at an elevation of 948.50 feet and rising at the rate of 4.943 per cent for a distance of 354.04 feet to an elevation of 966 feet at the east curb line of Castner avenue; thence beginning at the west curb line of Castner avenue, at an elevation of 967 feet, and rising at the rate of 5.5 per cent for a distance of 168 feet to an elevation of 976.24 feet at the east curb line of Meade street; thence rising at the rate of 2464 per cent for a distance of 112 feet to an elevation of 979 feet; thence falling at the rate of 1.151 per cent for a distance of 173.70 feet to an elevation of 977 feet at the east curb line of Waddell Avenue.

Beginning at the west curb line of Meldon Avenue, at an elevation of 783.6 feet, and rising at the rate of 12.314 per cent for a distance of 239 feet to an elevation of 813.03 feet at the east curb line of McKean Avenue; thence rising at the rate of 2.777 per cent for a distance of 36 feet to an elevation of 814.03 feet at the west curb line of McKean Avenue; thence rising at the rate of 14.335 per cent for a distance of 237 feet to an elevation of 848 feet at the east curb line of Thompson Avenue; thence rising at the rate of 5 per cent for a distance of 30 feet to an elevation of 849.5 feet at the west curb line of Thompson Avenue; thence rising at the rate of 11 per cent for a distance of 70.72 feet to an elevation of 857.28 feet at a point opposite the west curb line of Carroll Avenue; thence rising at the rate of 18.834 per cent for a distance of 189.65 feet to an elevation of 893 feet at a point opposite the east curb line of School Street: thence rising at the rate of 4.166 per cent for a distance of 24 feet to an elevation of 894 feet at a point opposite the west curb line of School Street; thence rising at the rate of 12.55 per cent for a distance of 174.63 feet to an elevation of 915.92 feet at the east curb line of Kenric Avenue; thence rising at the rate of 6.042 per cent for a distance of 24 feet to an elevation of 917. 37 feet at the west curb line of Kenric Avenue; thence rising at the rate of 5.828 per cent for a distance of 507.59 feet to an elevation of 946.95 feet at the east curb line of Allen Avenue; thence beginning at the west curb line of Allen Avenue at an elevation of 948.04 feet and rising at the rate of 4.943 per cent for a distance of 354.04 feet to an elevation of 965.04 feet to the east curb line of Castner Avenue; thence beginning at the west curb line of Castner Avenue; thence beginning at the west curb line of Castner Avenue, at an elevation of 976.24 feet at a point opposite east curb line of Meade Street; thence rising at the rate of 2.464 per cent for a distance of 112 feet to an elevation of 979 feet; thence falling at the rate of 1.151 per cent for a distance of 119. 56 feet to an elevation of 977.62 feet; thence falling at the rate of 5.64 per cent for a distance of 50 feet to an elevation of 974.80 feet at the east curb line of Waddell Avenue.

SECTION 2. All ordinances or parts thereof in conflict with any of the provisions of this ordinance, be and the same are hereby repealed.
