Mr. Migliori was advised that the reason there is no parking in front of Donora Towers is due to the fact that it is a FIRE LANE and not for any vehicles except Emergency Vehicles to park there.

Amber Trilli:

867 Thompson Ave - Regarding the newspaper article from the MVI on 07/14/2023, written by Max Robinette:

"While she spoke, Toprani found the property on the repository website and suggested a potential solution.

"The borough doesn't normally try to acquire properties," he said. "But this might be one we'd want to get control of. It would at least allow us to perform a demo perhaps."

Toprani said while government bodies often have limited authority over private property, unpaid taxes give municipalities a foot in the door.

"It wouldn't surprise me if this property has unpaid taxes. ... We'll call tax claim and see if we can potentially move on the house," he said. "I feel like a broken record because I say this every meeting: The Constitution protects bad property owners, too.

"What we have to be able to do, so we don't violate property rights, is simple: We get title to them. We have certain resources that we can use to perform demolitions. Cleaning up that eyesore will improve property values.

"If you were interested in purchasing those lots, put them back on the tax roll and give you extra space, that seems like something we can do. It's on the county list tonight — we just have to verify with tax collection before purchasing it."

Council President Mike McDowell said code enforcement and council members will continue to stay in contact with Trilli and update her on progress."
