

ORDINANCE NO. 1045 A

AN ORDINANCE OF THE BOROUGH OF DONORA, WASHINGTON COUNTY, PENNSYLVANIA, PROVIDING FOR ENTERING INTO A MANAGEMENT AGREEMENT WITH THE PARKING AUTHORITY OF THE BOROUGH OF DONORA, WASHINGTON COUNTY, PENNSYLVANIA; DEFINING THE TERMS, CONDITIONS AND COVENANTS OF THE AGREEMENT; AND DIRECTING THE PROPER OFFICERS OF THE BOROUGH TO ENTER INTO AND CONSUMMATE ON BEHALF OF THE BOROUGH A MANAGEMENT AGREEMENT WITH THE PARKING AUTHORITY OF THE BOROUGH OF DONORA, WASHINGTON COUNTY, PENNSYLVANIA.

WHEREAS, the Borough of Donora, Washington County, Pennsylvania, has entered into an Agreement of Lease, dated as of April 1, 1965, with The Parking Authority of the Borough of Donora, Washington County, Pennsylvania whereby the Borough has leased from the Authority the Authority's Off-Street Parking System; and

WHEREAS, the Authority has agreed to enter into a Management Agreement with the Borough as the Borough has requested the Authority to operate said Off-Street Parking System; and

WHEREAS, the Borough desires that the Authority operate said Off-Street Parking System and has so requested the Authority:

NOW, THEREFORE, be it ordained and enacted by the Council of the Borough of Donora, Washington County, Pennsylvania, and it is hereby ordained and enacted by authority of the same;

Section 1. The Borough shall enter into a management agreement with said Authority upon substantially the terms, conditions and covenants set forth in the form of Management Agreement to be dated as of April 1, 1965, presented to and read at this meeting which is hereby made a part hereof by reference only and is on file with the Borough Secretary.

Section 2. The Mayor and President of Council are hereby directed to execute, on behalf of the Borough, a Management

Agreement substantially in the form of the said Management Agreement, which agreement when executed shall be attested to by the Borough Secretary.

Section 3. That any ordinance or part thereof which may conflict herewith, or be repealed hereby, be and the same is hereby repealed.

Section 4. This ordinance shall take effect immediately upon final enactment.
