ORDINANCE NO. 1055

AN ORDINANCE OF THE BOROUGH OF DONORA APPROVING THE EXECUTION AND DELIVERY OF A PURCHASE AGREEMENT BETWEEN MON VALLEY SEWAGE AUTHORITY AND THE BOROUGH OF DONORA AND THE CITY OF MONESSEN, WESTMORELAND COUNTY, PENNSYLVANIA.

WHEREAS, the Borough of Donora and the City of Monessen have requested Mon Valley Sewage Authority to construct a preliminary sewage collection and treatment system to serve certain portions of the Borough of Donora and the City of Monessen and certain adjacent territories; and

WHEREAS, the Authority has agreed to construct said system and to that end has entered into an engineering contract with the Consulting Engineering firm of Gannett, Gleason, Gurdley & Carpenter, Inc., of Harrisburg, Pennsylvania, to prepare the necessary plans and specifications to construct the aforesaid project; and

WHEREAS, pursuant to the terms of said engineering contract, the said Consulting Engineers have prepared preliminary plans and specifications for the aforesaid project and heretofore received payment therefore under the terms of an Advance Planning Loan from the Department of Housing and Urban Development of the Federal Government; and

WHEREAS, due to restrictions in said planning money from Government agencies imposed by the present state of the national economy, it is not possible to obtain the balance of money needed through an Advance Planning Loan from said Department of Housing and Urban Development for the preparation of final plans and specifications; and

WHEREAS, in order for the said Authority to finance the preparation of the said final plans and specifications, it is therefore necessary for the Borough of Donora to enter into a Purchase Agreement with Mon Valley Sewage Authority and the City

of Monessen.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Donora, and it is hereby ordained and enacted by authority of the same as follows:

SECTION 1. The Borough of Donora shall enter into an agreement with Mon Valley Sewage Authority and the City of Monessen substantially in the form of the Purchase Agreement presented to this meeting, which is hereby made a part hereof by reference only and is on file with the Secretary of the Borough.

SECTION 2. The Mayor and President of Council are hereby directed to execute, on behalf of the Borough, an agreement substantially in the form of the said Purchase Agreement, which Purchase Agreement when consummated shall be attested to by the Borough Secretary.

SECTION 3. All ordinances or resolutions or parts of ordinances or resolutions not in accord with this Ordinance are hereby repealed insofar as they affect this Ordinance.
