

ORDINANCE NO. 1098

WHEREAS, the Borough of Donora desires to enter into an agreement with the Mon Valley Sewage Authority; and

WHEREAS, the Mon Valley Sewage Authority was organized and exists pursuant to the Act of May 2, 1945, P. L. 382, as amended, for the purpose of acquiring, holding, constructing, improving, maintaining, operating and owning sewers, sewer systems and sewage treatment works to serve the City of Monessen and the Borough of Donora and other customers in the service area of the Authority; and

WHEREAS, the Authority is presently engaged, at the direction of the City of Monessen and the Borough of Donora, in its initial project (hereinafter referred to as "Initial Project") which involves the construction of intercepting sewers, a treatment plant and necessary appendant structures, to serve those areas of the City of Monessen and the Borough of Donora which are presently served by sewer systems that discharge into the Monongahela River; and

WHEREAS, there are large residential areas within the Borough which are unsewered; and

WHEREAS, it is the desire of the residents of those areas that sanitary sewage facilities be constructed to serve those areas; and

WHEREAS, the Borough has indicated its willingness to extend the Donora sewage system to include these areas; and

WHEREAS, the Borough desires that the Authority undertake, in addition to and concurrently with its Initial Project, the construction of

collecting and intercepting sewers in the unsewered areas, said sewers to discharge into the present Donora sewer system, where possible, and eventually to the intercepting system which will be a part of the Initial Project; and

WHEREAS, a service agreement will be entered into by the Borough, the Authority and the City of Monessen covering the Initial Project of the Authority (which service agreement may hereinafter be referred to as the "Initial Service Agreement"); and

WHEREAS, the Authority and the Borough are desirous of entering into an agreement to accomplish the aforesaid objects:

NOW, THEREFORE, be it ordained and enacted by the Council of the Borough of Donora and it is hereby ordained and enacted by the authority of the same, as follows:

SECTION 1. That the proper officers of the Borough of Donora be and they are hereby authorized and directed in the name of the Borough as and for its act and deed to execute, acknowledge and deliver to the Mon Valley Sewage Authority an agreement for the construction of collecting and intercepting sewers in certain unsewered areas of the Borough of Donora.
