

ORDINANCE NO. 1107

AN ORDINANCE OF THE BOROUGH OF DONORA AUTHORIZING THE CONSTRUCTION OF A BOROUGH ROAD FROM THE INTERSECTION OF WASHINGTON STREET IN DONORA BOROUGH TO THE CARROLL TOWNSHIP AND DONORA BOROUGH LINES, WASHINGTON COUNTY, PENNSYLVANIA.

WHEREAS, the Borough of Donora desires to construct a local access road within the Borough of Donora, and to receive financial aid in connection with the construction costs thereof through the Appalachian Regional Development Act of 1965; and

WHEREAS, the Borough of Donora desires to enter into an Agreement with the Commonwealth of Pennsylvania, Department of Highways, so that the design, construction and specifications for the said road shall be approved by the said Department of Highways and to set forth the manner in which these construction costs in excess of those available from the Federal Government shall be paid.

NOW, THEREFORE, be it ordained and enacted by the Council of the Borough of Donora, in regular meeting assembled, and it is hereby ordained and enacted by virtue of the authority in them vested, as follows, to wit:

1. The construction of the local access road from the intersection of Washington Street in Donora Borough to the Carroll Township and Donora Borough lines, Washington County, Pennsylvania, is hereby authorized to be constructed upon the land heretofore conveyed to the Borough of Donora by the following deeds:

(a) Deed of Middle Monongahela Industrial Development Association, Inc. to Borough of Donora, dated October 1, 1969, and recorded in the Recorder's Office in Washington County, Pennsylvania, in Deed Book Volume 1309, page 1181.

(b) Deed of Middle Monongahela Industrial Development Association, Inc. to Borough of Donora, dated October 1, 1969, and recorded in the Recorder's Office in Washington County, Pennsylvania, in Deed Book Volume 1309, Page 1176.

2. The provisions of the Act of Congress of the United States known as "The Appalachian Regional Development Act of 1965", approved May 9, 1965, 79 Stat. 5, and Act No. 29 (a) of the Pennsylvania General Assembly, Legislative Session of 1966, approved May 30, 1966, providing for participation by the Commonwealth of Pennsylvania in such projects are hereby acknowledged and accepted in connection with the construction of said road.

3. The Mayor and Secretary of the Borough of Donora are hereby authorized to enter into an Agreement with the Commonwealth of Pennsylvania, Department of Highways, as required in connection with the construction of said road. The said Agreement, which is attached to this Ordinance, is hereby approved as to substance and form.




