

ORDINANCE NO. 1206

(4 of 1983)

AN ORDINANCE OF THE BOROUGH OF DONORA NAMING AND DESIGNATING CERTAIN STREETS IN THAT AREA KNOWN AS THE INDUSTRIAL PARK.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Donora as follows:

SECTION ONE: That the Street presently existing in the Industrial Park which commences at the termination of Scott Street and runs in a southward course parallel to Meldon Avenue on the West and the Monongahela River on the East a distance of four thousand four hundred forty-nine (4,449) feet and terminates at a heretofore unnamed street shall henceforth be known as GALIFFA DRIVE.

SECTION TWO: That the Street presently existing in the Industrial Park which runs the same course as Eighth Street in an eastward direction to the Monongahela River, intersects and is perpendicular to Galiffa Drive and is four hundred fifty-six (456) feet in length shall henceforth be known as EAST EIGHTH STREET.

SECTION THREE: That the Street presently existing in the Industrial Park which runs the same course as Sixth Street in an eastward direction to the Monongahela River, intersects and is perpendicular to Galiffa Drive and is four hundred forty (440) feet in length, shall henceforth be known as EAST SIXTH STREET.

SECTION FOUR: That the Street presently existing in the Industrial Park which runs the same course as First Street in an eastward direction to Washington Street, is perpendicular to the right of way formerly of the Penn Central Railroad and is eight hundred eighty (880) feet in length shall henceforth be known as EAST FIRST STREET.

SECTION FIVE: That the Street presently existing in the Industrial Park which forms a ninety degree angle to and with said Washington Street, runs

in a westward direction perpendicular to the right of way formerly of the Penn Central Railroad for a distance of seven hundred seventy-five (775) feet, makes a right angle and then runs parallel to the right of way formerly of the Penn Central Railroad a distance of one thousand one hundred fifty (1,150) feet to the Borough's corporate limits shall henceforth be known as SOUTH WASHINGTON STREET.

SECTION SIX: That GALIFFA DRIVE, EAST EIGHTH STREET, EAST SIXTH STREET, EAST FIRST STREET and SOUTH WASHINGTON STREET shall be placed on the Borough's Plan and designated as such according to the terms of this Ordinance.
