

ORDINANCE NO. 1241

AN ORDINANCE OF THE BOROUGH OF DONORA
RECLASSIFYING CERTAIN ZONING DISTRICTS
WITHIN THE MUNICIPAL CORPORATE LIMITS

BE IT ORDAINED AND ENACTED by the Council of the Borough of Donora, Washington County, Pennsylvania, as follows:

SECTION ONE: Certain Zoning Districts, because of public necessity and convenience, are hereby redesignated.

SECTION TWO: Attached hereto and incorporated by reference is the Zoning District Map amended and correlated as follows:

A. Those areas designated with RED shall remain conservancy "S" districts.

B. Those areas designated with BLUE shall henceforth be 'R1-B' districts, i.e. one family residence. These areas were formerly 'S' districts.

C. Those areas designated with YELLOW shall henceforth be 'R1-C' districts, one family residence. These were formerly 'S' districts.

D. Those areas designated with GREEN shall henceforth be 'M1', Light Industrial districts.

E. Those areas designated with PURPLE shall henceforth be 'R-3', Multiple Family Residence.

SECTION THREE: This Ordinance shall take effect after the procedure stated in Ordinance 1034 with regard to amendments to the same is accomplished.

'R1-C' districts, one family residence. These were formerly 'S' districts.

D. Those areas designated with GREEN shall henceforth be
'M1', Light Industrial districts.

*E. These areas designated with PURPLE shall henceforth be
'R3', Multiple Family Residence.*

SECTION THREE: This Ordinance shall take effect after the procedure
stated in Ordinance 1034 with regard to amendments to the same is accomplished.
