

ORDINANCE NUMBER 358

ESTABLISH GRADE OF AILES STREET BETWEEN ACME ALLEY AND FAYETTE AVENUE

AN ORDINANCE ESTABLISHING OR RE-ESTABLISHING THE GRADE OR GRADES OF AILES STREET BETWEEN ACME ALLEY AND FAYETTE AVENUE, IN THE BOROUGH OF DONORA, WASHINGTON COUNTY, PENNSYLVANIA.

BE IT ORDAINED AND ENACTED, by the Burgess and Town Council of the Borough of Donora, and it is hereby ordained and enacted by the authority of the same:

SECTION I.

That the grade of Ailes Street between Acme Alley and Fayette Avenue in the Borough of Donora be and the same is hereby established and fixed as follows:

SECTION II.

NORTH CURB LINE: Beginning at the angle point in the curb line at the west line of Acme Alley at an elevation of 875.79 feet, thence level for a distance of 32.55 feet to an elevation of 875.79 feet, thence falling at the rate of 9.838 per cent for a distance of 28.36 feet to an elevation of 873.00 feet, thence falling at the rate of 14.048 per cent for a distance of 156.61 feet to an elevation of 853.81 feet, thence by a parabola curve for a distance of 40.00 feet, to an elevation of 853.04 feet, thence rising at the rate of 10.184 per cent for a distance of 78.19 feet to an elevation of 861.00 feet at the east curb line of Fayette Avenue.

SOUTH CURB LINE: Beginning at the east curb line of Thompson Avenue at an elevation of 875.79 feet, thence crossing Thompson Avenue to the west curb line thereof at an elevation of 873.00 feet, thence falling at the rate of 14.048 per cent for a distance of 156.61 feet to an elevation of 853.81 feet, thence by a parabola curve for a distance of 40.00 feet to an elevation of 853.04 feet, thence rising at the rate of 20.626 per cent for a distance of 43.44 feet to an elevation of 862.00 feet, at the east curb line of Fayette Avenue.

SECTION III.

All ordinances or parts thereof in conflict herewith are hereby repealed.
