

ORDINANCE NUMBER 360

ESTABLISHING GRADE OF VAN PELT STREET BETWEEN THOMPSON AND MARELDA AVENUES

AN ORDINANCE ESTABLISHING OR RE-ESTABLISHING THE GRADE OR GRADES OF VAN PELT STREET BETWEEN THOMPSON AVENUE AND MARELDA AVENUE, IN THE BOROUGH OF DONORA, WASHINGTON COUNTY, PENNSYLVANIA.

BE IT ORDAINED AND ENACTED by the Burgess and Town Council of the Borough of Donora, and it is hereby ordained and enacted by the authority of the same:

SECTION I.

That the grade of Van Pelt Street between Thompson Avenue and Marelda Avenue in the Borough of Donora be and the same is hereby established and fixed as follows:

SECTION II.

NORTH CURB LINE: Beginning at the west curb line of Thompson Avenue at an elevation of 864.31 feet, thence rising at the rate of 2.17 per cent for a distance of 140.00 feet to an elevation of 867.35 feet, thence by a parabola curve for a distance of 60.00 feet to an elevation of 870.46 feet, thence rising at the rate of 8.192 per cent for a distance of 171.16 feet to an elevation of 884.48 feet, thence rising at the rate of 14.327 per cent for a distance of 44.67 feet to an elevation of 890.88 feet, thence rising at the rate of 13.834 per cent for a distance of 44.67 feet to an elevation of 897.06 feet, thence rising at the rate of 16.0 per cent for a distance of 55.90 feet to an elevation of 906.00 feet at the east curb line of Marelda Avenue.

SOUTH CURB LINE: Beginning at the west curb line of Thompson Avenue at an elevation of 863.31 feet, thence rising at the rate of 3.761 per cent for a distance of 49.72 feet to an elevation of 865.18 feet, thence rising at the rate of 2.17 per cent for a distance of 100.00 feet to an elevation of 867.35 feet, thence by a parabola curve for a distance of 60.00 feet to an elevation of 870.46 feet, thence rising at the rate of 8.192 per cent for a distance of 171.16 feet to an elevation of 884.48 feet, thence rising at the rate of 16.0 per cent for a distance of 134.60 feet to an elevation of 906.00 feet at the east curb line of Marelda Avenue.

SECTION III.

All ordinances or parts thereof in conflict herewith are hereby repealed.
